Eagle-Research WaterTorch technology has been used safely and effectively since 1995.

1. DISCLAIMER.

The WaterTorch™ (WT) and operation instructions are sold for experimental purposes, to allow experimentation with Brown's Gas (BG). This WT™ is specifically designed for single operator-monitored use. The ER1200 WaterTorch™ is not designed for automatic or industrial applications. The Buyer assumes full responsibility for use or misuse of the WT and the resulting BG produced. ALL SALES ARE FINAL.

2. LIMITED WARRANTY.

The Water Torch Collective Ltd. (WTC) warrants that the WT sold hereunder will be free from defects in material and workmanship for a period of one year from the date of shipment. This Limited Warranty is extended to the Original Buyer of the WT who bought directly from an authorized WTC Distributor. If the WT does not conform to this Limited Warranty, Buyer shall notify WTC in writing. If the defects are reported within the warranty period, WTC reserves the right to choose repair, replace or refund and will cover the costs of shipping, parts and labor. Complete technical support is available. Problems caused by improper use of the WT can be repaired at Buyer's expense.

3. OTHER LIMITS AND STATEMENTS.

The foregoing is in lieu of all other warranties, express or implied, including but not limited to the implied warranties of merchantability and fitness for a particular purpose.

WTC does not warrant against damages or defects out of improper or abnormal use or handling of the WT; against defects or damages arising from improper installation (where installation is by persons other than WTC), against defects in products or components not manufactured by WTC, or against damages resulting from such non-WTC made products or components. WTC passes on to Buyer the warranty it received (if any) from the maker thereof of such non-WTC made products or components. This warranty also does not apply to a WT upon which repairs have been effected or attempted by persons other than pursuant to written authorization by WTC. The exclusive obligation of WTC shall be to repair or replace a defective WT in the manner and for the period provided above. WTC shall not be liable for any loss, direct or indirect, incidental, special, or consequential damage arising out of the use of or in connection with the WT. No agent, employee or representative of WTC has any authority to bind WTC to any representation or warranty relating to the WT other than specifically provided herein.

4. APPLICABLE LAW.

Specific legal rights and other rights vary from jurisdiction to jurisdiction. This Agreement is governed by the laws of British Columbia. British Columbia courts have exclusive jurisdiction over matters arising out of this agreement.
